Re: Due Process Decision

Dear Mr. Lambert, Sr.:

On Friday, April 21, 2017, you participated in a Due Process Conference to review the recommendation of appropriate disciplinary action for willful neglect of duty. The recommendation was made by Ms. Maria Landry, Principal of John Ehret High School, for willful neglect of duty and allegedly participating in falsified information being sent to the LHSAA for the purposes of attaining student eligibility for sports.

During the conference, you were given the opportunity to present oral and documentary evidence. Likewise, Principal Landry presented evidence and discussed the performance, responsibilities, and expectations for your role as a Head Coach with the Jefferson Parish Public School System.

After reviewing the evidence and investigative material, and final determination made by the LHSAA, it has been determined that the allegations against you cannot be confirmed. You were placed on suspension without pay on March 24, 2017, from your coaching duties during the investigation. The investigation has been completed and you were returned to your coaching duties on April 18, 2017. Any loss of pay during this time will be retroactively paid back to you.

It should be noted that the LHSAA did place the following sanctions:

 The John Ehret High School has been placed on probation for the sports of Boys' Outdoor Track, Boys' Basketball, and Football for one (1) calendar year.

2. John Ehret High School has been fined \$1,000.00.

 Corey Lambert, Sr., is required to complete the LHSAA Handbook Certification Course and complete and pass the NFHS Online Fundamentals of Coaching Course before the end of the 2016-17 academic school year.

Human Resources is closing this disciplinary matter. I wish you a successful remainder of the 2016-2017 school year.
